Dear Mr. Permink:

It was a pleasure speaking with you concerning Employers' Information Service (E.I.S.). Below is a summary of the information we discussed.

Briefly, E.I.S. is a service organization, that maintains a repository of data useful to member companies in screening employment applications. This data is of three types:

- 1) Abstracts of workers' compensation claims and/or suits filed in Texas, Oklahoma, New Mexico, Louisiana, Mississippi, Tennessee, and Alabama.
- 2) Reports by member companies of work related injuries.
- 3) Reports from member companies of employee separations. Although these reports do not state the reason for separation or termination, they do state the dates of employment and whether or not the employee is eligible for rehire.

As can readily be seen, when a company calls E.I.S. to screen a job applicant, there is often a wealth of information available. You will know if the applicant has sustained industrial accidents as evidenced by workers' compensation suits against former employers, the work history from prior employment with member companies, and the history of prior job injuries.
